<b>Radiation Oncology Poster Presentation Prize</b>  Sponsored by AlphaXRT	Awarded to the best poster related to Radiation Oncology at the EPSM 2017 conference.  Eligibility Criteria: <ul style="list-style-type: none"><li>• Abstract to be submitted under the “Radiation Oncology” category.</li><li>• The Scientific Committee will confirm the suitability of the submitted abstract for the radiation oncology category.</li></ul>
<b>EPSM 2017 Committee Poster Presentation Prize</b>  Sponsored by ACPSEM Foundation Limited	Awarded to the best poster in any field of physical science and engineering in medicine other than radiation oncology at the EPSM 2017 conference.  Eligibility Criteria: <ul style="list-style-type: none"><li>• Abstract to be submitted in a category other than Radiation Oncology.</li><li>• The Scientific Committee will confirm the suitability of the submitted abstract for a category other than radiation oncology.</li></ul>

## Judging Criteria

The eligible presentations will be voted on by judges appointed by the Scientific Committee. All abstracts nominated for a prize during the abstract submission process will be reviewed by the Scientific Committee and the top 10 abstracts in each category will be shortlisted prior to the conference. Judges for each category will attend all shortlisted presentations in their category. The judges' decisions will be final. Presentation of the Awards will be made at the closing ceremony.

Oral Presentations will be judged based on:

- Quality – strong technical content
- Originality – with emphasis on original work as opposed to reviews
- Clarity – quality of delivery, ease of comprehension
- Presentation – good audio-visual presentation (organisation, use of images, graphs and tables), keeping to time limit.
- Value – relevance to Medical Physics and to the wider community.

Poster Presentations will be judged based on:

- Quality – strong technical content
- Originality – with emphasis on original work as opposed to reviews
- Clarity - quality of presentation, ease of comprehension
- Presentation - good visual presentation (organisation, use of images, graphs and tables), effective use of space.
- Value – relevance to Medical Physics and to the wider community.

Invited speakers are not eligible for these prizes.
